What is your Emergency Plan for Excessive Heat Events?

The 2010 Summer has been the most severe heat Alabama has ever seen. Starting in May the temperatures were in the high 90's and have been over 100 degrees for a couple of months. What are we doing to warn our citizens? Do you have an Excessive Heat Event (EHE) plan?

The U.S. Environmental Protection Agency has produced the Excessive Heat Events Guidebook with assistance from Federal, state and local and academic partners.

The handbook is designed to help community officials, emergency managers, meteorologists, and others plan for and respond to excessive heat events as it highlights best practices that have been employed to save lives during excessive heat events in different urban areas and provides a menu of options that officials can use to respond to these events in their communities.

Useful Community Interventions For Public Officials:

- Send a clear public message
- Communicate that EHEs are dangerous and conditions can be life-threatening. In the event of conflicting environmental safety recommendations, emphasize that health protection should be the first priority.
- Inform the public of anticipated EHE conditions and how dangerous it will be?
- How long will EHE conditions last?
- How hot will it feel at specific times during the day (e.g., 8 a.m., 12 p.m., 4 p.m., 8 p.m.)?
- Assist those at greatest risk

- Assess locations with vulnerable populations, such as nursing homes and public housing
- Staff additional emergency medical personnel to address the anticipated increase in demand
- Shift/expand homeless intervention services to cover daytime hours
- Open cooling centers to offer relief for people without air conditioning and urge the public to use them.
- Provide access to additional sources of information
- Provide toll-free numbers and Web site addresses for heat exposure symptoms and responses
- Coordinate broadcasts of EHE response information in newspapers and on television and radio.

Communities can adopt development strategies to reduce heat islands and coordinate local efforts:

Urban and suburban areas can be "heat islands," a zone 2-10 degrees F warmer than the surrounding rural countryside. Because they are warmer, heat islands use more energy to keep cool, which raises costs and reduces air quality.

Communities can invest in long- term strategies such as:

- ⇒ Promoting or installing cool or vegetated "green" roofs
- ⇒ Planting more trees and vegetation
- ⇒ Switching to cooler paving materials.

Statewide Disaster Committee Meets!

ACCA's Government Relations Specialist, Sim Pettway, Jr., attended the Alabama Disaster Recovery Program Committee (ARDC) meeting on July 19th as they adopted rules and regulations for the program. Also established was a guidance document to help counties prepare to meet requirements of the law. Counties should expect to see the document in the coming months.

The committee was formed through SB160 (ACT No. 2009-342) to help provide assistance to counties and municipalities to meet local needs during and immediately following disasters. The eight member committee is made up of state and local officials and employees, including; **Eric Jones, Elmore County EMA Director; Dennis McCall, Butler County Engineer; Bill Strickland, Marshall County Commissioner; Ted Jenkins, Mayor, City of Brewton; Josh Blades, Deputy Chief of Staff for Governor Riley; Dan Jackson, Alabama Forestry Commission; Ed Phillips, ALDOT State County Transportation Engineer and Brock Long, AEMA Director.** ARDC has several challenges to meet, including funding for the program. The committee plans to discuss funding options at their next meeting.

Oil Spill Update!

Facts As Of July:

- Approximately 622 miles of Gulf Coast shoreline is currently oiled—approximately 355 miles in Louisiana, 111 miles in Mississippi, 69 miles in Alabama, and 87 miles in Florida. These numbers reflect a daily snapshot of shoreline currently experiencing impacts from oil so that planning and field operations can quickly respond to new impacts; they do not include cumulative impacts to date, or shoreline that has already been cleared.
- From the Mobile, Ala., Incident Command Post, 39 two-person teams, 24 support personnel and 11 vessels responded to wildlife recovery. You may check www.restorethegulf.org for more up to date information.

82nd Annual Convention will focus on applying these innovative ideas here in Alabama's 67 counties.

"We're excited about this opening session," said ACCA Executive Director Sonny Brasfield, "because it should provide counties with ideas that can translate into a positive impact back home."
